Statement of the Richard Stenzhorn GmbH to

Regulation EG Nr. 1907/2006 Regarding the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) of 07th, November, 2024

Our company is not manufacturer, producer or importer of chemicals within the meaning of Articles 6 and 7 of REACH, but is included in the system as a so-called "downstream User".

According to article 33 of the Reach regulation, product suppliers must inform the customer whether substances from the Reach candidate list (SVHC-list) are greater than 0,1% weight potential.

According to information currently available to us, some components contain the SVHC substance lead (Pb), CAS number 7439-29-1, as an alloying element, e.g. copper alloys in brass, in concentrations greater than 0,1%. The use of this substances complies with the applicable relevant legal regulations. When used as intended according to customer specifications safe use is basically ensured and there is no danger to health or the environment.

The following materials contain Lead (Pb, a substance of very high concern:

- CuZn36Pb3
- CuZn39Pb2
- CuZn39Pb3
- CuZn38Pb1,5
- CuBe2Pb (BeCu33-25)

We oblige our suppliers to comply with REACH in order to receive the necessary information about SVHC substances in the supply chain if required. Our products do not contain any of the listed substances according Appendix XIV.
